Promoting Sustainability Management

Basic Approach to Sustainability

Society is undergoing rapid changes, as exemplified by environmental issues, the declining birthrate and aging population, and human rights issues. In the midst of these changes, we at the NIKKON Group are determined to contribute to national and local communities by squarely facing the issues at hand and creating new value with all stakeholders through our logistics business, thereby realizing a sustainable society and enhancing our corporate value.



System for Promoting Sustainability Management

The NIKKON Group believes that enhancing systematic measures regarding its environmental, social, and governance (ESG) criteria is one of management's most important tasks. To achieve this, we have established a system in which directors directly supervise ESG activities and quickly formulate policies and provide guidance, so as to promote highly effective ESG activities. In July 2021, the ESG Promotion Office was established as the team responsible for implementing ESG activities. As part of the office, working groups made up of members from eight core companies lead Group-wide activities. The Sustainability Committee, which was established in October of the same year, serves as an organization under the direct control of the director supervising ESG activities. It supervises and provides guidance on overall ESG activities, including diversity and environmental action, from the perspective of shareholders and other stakeholders.



Materiality map



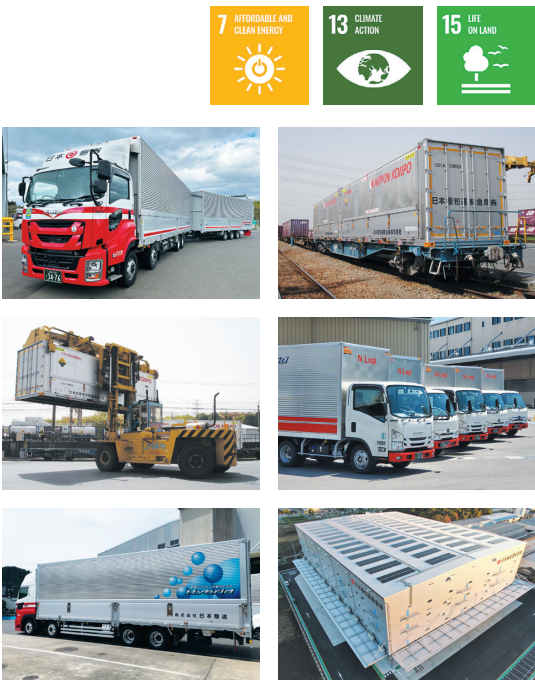

Basic Approach

The NIKKON Holdings Group believes that it has a social responsibility to protect and maintain the global environment through sound business activities. We continuously engage in environmental conservation activities to achieve carbon neutrality by 2050

- Shift of main line vehicles from large trucks to full trailers
  - 21-meter and 23-meter full trailers
- Expansion of consolidated transportation and cooperative delivery
- Promotion of modal shift
  - Railroad: 31-foot private containers, etc.
  - Domestic vessels: (manned, semi-trailers and uncrewed transportation of self-propelled products)
- Introduction of eco-friendly vehicles
  - Electric trucks and hybrid vehicles
- Installation of solar panels and shift to renewable energy
  - On-site PPA
  - Self-owned
- Shift from mercury lamps and fluorescent lamps to LEDs
- Introduction of air-conditioning demand control systems
